How CDBX Works

- » Register and complete payment by April 17, 2026 deadline.
- » Each company creates a minimum of one distributor team. However, we encourage distributor companies to create at least two teams (ex. tobacco and non-tobacco teams) to maximize meetings and the value of attending CDBX.
- » The Team Lead Contact will be given access to the CDBX MeetMax system to rate suppliers for each team from high to low, and then rank them in order of priority on the system. Suppliers will also rate and rank distributor teams at CDBX.
- » The week of July 13, the Team Lead Contact will receive the team's schedule, along with full contact information for supplier teams to enable agenda development for each meeting.
- » Each business exchange meeting lasts 35 minutes, with 10 minute breaks between each meeting.
- » Suppliers have fixed meeting rooms and distributors move from meeting to meeting.
- » Breakfast and lunch are included each day, along with three evening receptions and a hospitality space with refreshments for the duration of CDBX. All are included with registration.

How to Register

Companies registered by the deadline may continue to add or update attending personnel.
