The acquisition of these nine locations by PFSbrands promises to uphold the legacy and community-focused philosophy that Moser's has built over four decades.

Speaking about the transition, Moser expressed his satisfaction and optimism for the future: "I am pleased to be selling our business to a local company that will allow our Moser's legacy to continue. All of our dedicated employees will be able to become employee-owners at PFSbrands and will have the opportunity to maintain their current positions. I've
