#### SBA EMERGENCY DISASTER RELIEF LOANS

On 3/12/20, the Small Business Administration (SBA) <u>announced</u> disaster assistance loans of up to \$2 million would be available for small businesses affected by COVID-19. The low-interest loans are for businesses that have sustained "substantial economic injury" due to the spread of the coronavirus. The SBA's Office of Disaster Assistance will coordinate with state governors that submit relief requests. <u>Coronavirus (COVID-19): Small Business Guidance & Loan Resources</u>. ## FAMILIES FIRST CORONAVIRUS RESPONSE ACT

The Senate passed the Families First Coronavirus Response Act, an economic stimulus plan aimed at addressing the impact of the COVID-19 outbreak on Americans and introducing paid sick leave and an expanded family and medical leave act to the nation's employers. The DOL published guidance explaining the paid sick leave and expanded FMLA.

# PAYCHECK PROTECTION PROGRAM

The U. S. Small Business Administration announced the Interim Final Rule of the CARES Act which temporarily adds the <u>Paycheck Protection Program</u> to the SBA's 7(a) Loan Program. The program provides small businesses with funds to pay up to 8 weeks of payroll costs including benefits. Funds can also be used to pay interest on mortgages, rent, and utilities. #### **GUIDANCE FOR EMPLOYERS TO PLAN AND RESPOND TO COVID-19**

The US Chamber of Commerce shared guidance that may help prevent workplace exposures to acute respiratory illnesses, including the coronavirus, in non-healthcare settings.
